## Dear Sir / Madam,

Due to Resource Consent conditions from Councils, and the Waste Minimisation Act which as directed by Ministry for the Environment (MfE), Road Metals are required to have a signed written agreement with our clients to acknowledge that materials deposited at our Cleanfill sites meet with all acceptance criteria of our consents and within MfE requirements and guidelines, specifically that material shall only comprise acceptable cleanfill material as set out in section 4.2 of the 2002 MfE Guide to Management of Cleanfills 2002.

No material will be accepted from a site that has been identified as a Hazardous Activities and Industries (HAIL) on the Listed Land Use register (LLUR) unless a Detailed Site Investigation has been undertaken by a SQEP (suitably qualified and experienced environmental practitioner) in accordance with the National Environmental Standard for Assessing and Managing Contaminants in Soil to Protect Human Health.

Anyone transporting material from a site that has a Detailed Site Investigation report must forward that report to Road Metals for approval at least 2 days prior to transporting such materials to a Road metals Cleanfill location, with Road Metals advising what cleanfill location is suitable for the disposal.

All details as to where the Cleanfill material originates from and who has deposited the material is recorded at our Cleanfill sites and if contaminated material was found to be deposited then it will be the clients responsibility to remove the material, at their own cost and any additional costs associated with such removal.

Should any client not remove such contaminated materials, within an agreed time frame, Road Metals will remove and supply to an approved waste dumping site, with all costs invoiced to the client.

By signing this agreement your company is confirming that the material deposited is in compliance with the outlined acceptance criteria and your company is agreeing to the conditions above.

This agreement covers all Cleanfill sites operated by Road Metals

- Rolleston Quarry
- Corbett Road Quarry
- Harewood Gravels Quarry
- Diversion Road Quarry (Transfer site only)
